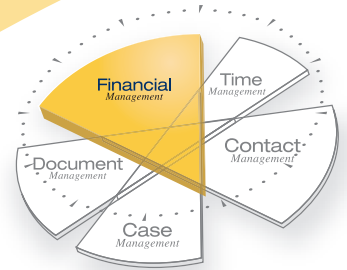

Get paid faster. Recent studies have shown that by accepting forms of integrated electronic payments, firms are able to greatly reduce both collection time and costs associated with receiving checks sent via mail.

According to a recent survey, firms that collect 75% or more of their payments electronically collect half of their bills within three days of issuing them. These same firms also reported an increase in cashflow as a result of accepting credit/debit cards, ACH and eChecks as forms of payment.

- Accepting credit cards led to an average of \$831 in additional payments per month = nearly \$10,000/year.
- Helpful Reductions. Client tension around payment was reduced by nearly 56% and administrative work decreased by 41%. And 46% of firms reported that accepting forms of electronic payments was a business development advantage, because it gave clients what they wanted.
- Accepting credit/debit cards also eliminates the hassle of dealing with bounced checks and the associated bank fees.
